The protective footwear for motorcycles riders model "Boot 5.5 FlexLock" is produced in the following sizes: 40.5-42-43-44.5-45.5-47-48 (European sizes) or 7-8-9-10-11-12-13 (United States sizes). The device is closed in the lateral part by means of buckles and a velcro strap. Upper of the device made by PU microfiber and leather; lining made by textile + foam, microfiber and PU stretch; outsole made by vulcanized rubber (code SOL19 and SOL20 for Enduro variants), insole made by non-woven material and PP (code KKPP) and insock made by textile mesh + EVA (code FBL19). Enduro variants differ from the others, as well as for the colour, for a different sole pattern.

The present EU Type-Examination Certificate is the third revision of the previous one issued by Dolomiticert Scarl in date 19/07/2019 with number EC 19-0181. The first revision, issued in date 08/05/2020, considers the introduction of three new variants and the change of the model identification (from "Boot GTX 5.5 Flexlock" to "Boot 5.5 Flexlock"). The second revision, issued in date 22/01/2021, considers the introduction of three new variants (Aqua and Enduro Cactus and Graphene). The present revision considers the introduction of five new variants (Fuel, Red, Tiger, Wht and Enduro JW22 updated).


